In consideration of my receiving from Old English Sheepdog Rescue of Southern California, Inc., the Old English Sheepdog described below, I hereby agree to care for this dog humanely (including food, grooming, shelter and veterinary care), and to license this dog in accordance with the laws in the jurisdiction in which I reside.

X_____ I AGREE not to give away, sell, trade, or dispose of this dog in any way, but to return this dog to the Old English Sheepdog Rescue of Southern California, Inc. Representative listed above if at any time I wish to relinquish custody. I FURTHER AGREE that the dog shall not be used for medical or other experimental purpose.

And, if not satisfied with the conditions in which the dog is being kept, said dog may be reclaimed by the Rescue Representative immediately. I also understand that I must inform OES Rescue of any change in address or phone number.
